

Special Education Preschool-to-Kindergarten Transition Timeline for Students with Autism Fairfax County Public Schools\*

### Last Year of Preschool

**Fall:** Attend the Preschool-to-Kindergarten Transition meeting for parents of special education preschoolers. You will be notified of the date and time by your child's preschool.

**Fall-Winter:** If your child is eligible for a triennial reassessment, decide on which assessments you will agree to have the school conduct. Once the assessment reports are finalized, you will meet with the school psychologist to discuss results and recommendations.

**Winter-Early Spring:** Start to think about options for kindergarten placement and services. The Least Restrictive Environment page of your student's IEP lists the various ways your child can access the general education curriculum.

#### General Education Participation:

Consider and document below the student's potential access to general education locations across the school day, e.g.:

- General Education Classes /Subjects
- Assemblies
- Natural Environment (ECSE only)
- · Recess (ES only)

- General Education Specials/Electives
- Adult/Community Setting
- Hallways/Transition
- Cafeteria
- Many students receive a combination of these options, dividing their time between settings and receiving special education assistance where needed. This is where it comes down to the INDIVIDUAL needs of your child and what you and the rest of the IEP team think is best for him or her.
- The Services page of the IEP breaks out the hours your child will receive special education services in the general education setting and the hours your child will spend in the special education setting only. The Service column will specify the type of special education services received, such as AUT for an enhanced autism classroom or NCE for a non-categorical special education classroom.

**Spring:** Schedule IEP meetings with your team and, if needed, observations with your Procedural Support Liaison (PSL). Find your PSL's contact information here: <u>https://www.fcps.edu/node/31223</u>

# Potential Kindergarten Classroom Setting Observations with Your PSL

- General education kindergarten classroom at student's base school
- Special education classroom at student's base school (if available)
- Special education classroom at another school that has a program that meets your child's needs, such as an enhanced autism classroom

# **Kindergarten Transition IEP Goals Meeting**

- Discuss both academic and non-academic goals. These goals can be revised once your child begins kindergarten, at any point in the year, as the new teacher has had time to work with your child.
- If a placement is not determined, then the IEP team will end the meeting and reconvene at another time.

# **Kindergarten Placement IEP Meeting**

- If needed, reconvene the IEP team to discuss placement options.
- If you agree with everything in the IEP, including but not limited to all goals, general education
  participation, special education hours and service settings, and placement, then provide consent and
  sign the IEP. If you disagree with any part of the IEP, work with the PSL to determine your consent
  options.
