# Can a student who struggles to pass the SOL earn a Standard Diploma?

Yes! Possible options to earn verified credit include:

- Substitute Assessments <u>Link</u> (accessible link in the notes section)
- Locally Awarded Verified Credit
  - Can be considered with students whose score is 375 or above, after remediation and attempt to retake
- Special Permission Locally Awarded Verified Credit Accommodation
  - Can be considered with students whose score is below 375, if the student meets the criteria



- Facilitate the FBA/ BIP team process
- Provide district, region, and school based professional development trainings


#### **ABA Programs**

- Opened 19 new Preschool Autism Classrooms (PAC)
- Opened 18 new Enhanced Autism Classrooms (EAC)
- Trained 71 PAC staff at Hands On Training
- Trained 51 Secondary and Elementary Staff at the August Hands

### **Twice Exceptional Learners**

- FCPS is continuing and deepening the work started several years ago with the collaborative creation of the 2e Handbook.
- In January 2023, FCPS invested in a new 2e specialist position to support this work on professional learning and leadership in schools to enact the handbook and serve students who are 2e.
- AAPAC is focusing in 2e this year. The charge for 2023-24 SY is: AAPAC will learn about research in the field of twice-exceptional (2e) and hear about central and school-based efforts to meet the needs of 2e learners in FCPS. There committee will make a report to the School Board (expected June 2024).
